



ndia is the world's second most populous country with more than 50 percent of its population under the age of 25 and more than 65 percent below the age of 35.The average age of the Indian youth is 29 years. In today's dynamic world, this unique demography presents a plethora of opportunities for investing in human capital development to boost the Indian economy. It is a fact that the stronger the youth, the more developed the nation is. Therefore, we can say that a country's youth is the core agent of progress, and contributor to economic and social development. Entrepreneurship promotion and development programs are being organized regularly by Ministry of MSME to nurture the talent of youth by enlightening them on various aspects of industrial/business activity required for setting up MSMEs. One of the major challenges faced by young entrepreneurs is the non-availability of adequate finance to carry out their operations. For this, ministry of MSME facilitates collateral free loans and there are also other schemes which provide financial assistance.

It is our role to establish an atmosphere that encourages creativity and gives possibilities for innovative and young business. 

PROGRESS UPDATE

MSME SAMBANDH - Public Procurement Policy:

Implementation of Public Procurement Policy for Micro and Small enterprises is monitored through the MSME SAMBANDH portal. Up to 30.12.2021, the procurement details of CPSEs during 2020–21 and 2021–2022 are as follows:

Guarantee Emergency Credit Line (GECL):

Under the Guarantee Emergency Credit Line (GECL) scheme, out of the total budgetary allocation of Rs. 10,000 crores, an amount of Rs.500 crore has been released to the implementing agency, i.e., National Credit Guarantee Trust Company (NCGTC) in December 2021. Till 31.12.2021, the total release to the said agency by the Ministry of MSME during the current financial year stands at Rs. 7,750 crore.

Credit Guarantee Scheme for Subordinate Debt (CGSSD):

It is operationalized through a special window created for this purpose under Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE). The scheme has been extended up to 31st March 2022.

During the FY 2021-22 (From 01.04.2021 to 28.12.02021), 283 guarantees have been approved involving an amount of Rs.26.45 crore.

Since inception, 756 guarantees amounting to Rs. 81.78 crore have been extended by 18 Banks.

Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE):

During December 2021, up to 27.12.2021, as per the data provided by CGTMSE, 35.504 guarantees have been approved involving an amount of Rs. 3,613.54 crore.

During the FY 2021-22 (from 01.04.2021 to 27.12.2021), a total of 4,95,911 guarantees have been approved involving an amount of Rs. 35.722.35 crore.

Prime Minister's Employment Generation Programme (PMEGP):

Margin Money Subsidy of Rs.1633.19 crore was disbursed by banks up to 31.12.2021, under the 'Prime Minister's Employment Generation Programme' (PMEGP) which will facilitate the setting up of 52984 micro-enterprises creating employment of around 423872 persons.

Capacity Building and Augmentation:

Training & Placement:

During December 2021, 18 Tool Rooms & Technical Institutions under the Office of Development Commissioner (MSME) trained 12,134 trainees. These Tool Rooms & Technical Institutions provide training & consultancy to industries, render facilities for upgrading technologies and provide skill training in specific product groups like Foundry & Forging, Electronics, Electrical Measuring instruments, Fragrance & Flavour, Glass and Footwear Industry etc.

269 trainees trained by MSME Tool Rooms & Technical Institutions viz., CTTC Bhubaneswar, IDTR Jamshedpur, CTTC Kolkata, TRTC Guwahati and PPDC Agra, have been placed in various enterprises like M/s Maruti Suzuki India Ltd, M/s Jindal Steel & Power Ltd M/s Tata Aerospace, M/s Azad Engineering Pvt. Ltd. M/s N.S. Engineering Pvt. Ltd. and various other enterprises located in Haryana, Chhattisgarh, Telangana, Maharashtra, Assam, Rajasthan, etc.

Skill Training under the Ministry is conducted through various organizations, i.e. Tool Room & Technical Institutions, New Technology Centres established under TCSP, National Small Industries Corporation (NSIC) Ltd., Khadi and Village Industries Commission (KVIC), Coir Board, etc. Up to 30th December 2021, 27,277 persons have been imparted skill training by these organizations.

TRTC, Guwahati has trained 1,614 Candidates in various Certificates, Diploma, and other Skill development courses.

Assistance & Handholding :

During December 2021, 18 Tool Rooms & Technology Institutions under the Office of Development Commissioner (MSME) assisted 2,607 units for job works, testing & calibration, and consultancy services. These Tool Rooms & Technology Institutions provide facilities for designing and manufacturing of dies and tools, moulds, jigs and fixtures, gauges and tool components, CAD/CAM, etc

Extension Centres (ECs):

17 ECs have started training/assisting MSMEs. In December 2021, 17 ECs have trained 925 trainees and assisted 37 MSMEs.

COIR Board:

Coir Board participated in 16 Domestic Exhibitions and has organized 8 exclusive Exhibitions in Connection with Azadi Ka Amrit Mahotsav during December 2021

Coir Board exported 65772 MT coir products worth Rs. 194.26 crore during December 2021.

Mahatma Gandhi Institute for Rural Industrialization (MGIRI):

Skill Development Training Programme based on Garment Manufacturing Technology organized by MGIRI from 07.12.2021 for two weeks for 1 beneficiary; on Pottery from 13.12.2021 for 45 days and Panchgavya Products from 20.12.2021 for 6 days for 12 participants from Maharashtra and West Bengal.


