On the occasion of International MSME Day, the Ministry of Micro, Medium Small & Enterprises, celebrated 'Udyami Bharat-MSME Day' on 27th June, 2023. The Union Minister for Ministry of Micro, Small & Medium Enterprises, Shri Narayan Rane graced the occasion as Chief Guest of the programme along with the Union Minister of State for Micro, Small & Medium Enterprises, Shri Bhanu Pratap Singh Verma as Guest of Honor.



The event showcased the launch of various initiatives of the Ministry of MSME, dedicated towards growth and development of MSMEs such as 'CHAMPIONS 2.0 Portal' and 'Mobile App for Geo-tagging of Cluster Projects and Technology Centers' by the Chief Guest and Guest of Honor. Further, results for 'MSME Idea Hackathon 2.0' were declared and 'MSME Idea Hackathon 3.0' for women entrepreneurs was launched.

Addressing gathering, Shri the Rane emphasized the Narayan **MSMEs** the importance of country's GDP and exports and expressed hope that MSMEs will contribute to 50% of the country's GDP by 2030.

He congratulated all stakeholders on the event's success and urged everyone to take steps towards making India a USD 5 trillion economy.

Appreciating the role of Indian MSMEs in the growth of the country's economy, Shri Bhanu Pratap Singh Verma highlighted, that since 2014, India's GDP ranking has seen a significant jump from 10th to 5th position.

About the Ministry



Registration of MSMEs

2,187,183 MSMEs registered on the Udyam Registration Portal in the month of June, July and August, 2023. Since the launch of the Portal w.e.f. 01.07.2020 till 28.08.2023, as many as 2.47 crore MSMEs have registered on Udyam Portal, including 59,78,687 registration of Informal Micro Enterprises (IMEs) on Udyam Assist Portal.

EXPORT PROMOTION

- Information on exports and imports is provided currently by the Directorate General of Commercial Intelligence and Statistics (DGCI&S), in which specific information to MSME sector is not available. In order to have real time data on exports and imports done by MSMEs, there is a need to link ICEGATE portal of Central Board of Indirect Taxes & Customs (CBIC) with Udyam Registration portal of the Ministry of MSME. In this regard, a meeting was held under the Chairmanship of Additional Secretary and Development Commissioner (MSME) with CBIC on 02.06.2023 and deliberations are in progress with CBIC for capturing data for MSME sector from ICEGATE software.
- 54 Export Facilitation Centers (EFCs) functioning across the country which are disseminating information to the MSME Sector on import and export procedures, have assisted more than 78 entrepreneurs in the month of August, 2023.

The second meeting of India-Japan Joint Working Group (JWG) on MSME Cooperation, constituted under the India-Japan Industrial Competitiveness Partnership Roadmap (IJICP), was held on 13.07.2023 in virtual mode. The meeting was led by Ms. Mercy Epao, Joint Secretary (SME) from Indian side and Mr. Katsuhiko Murayama, Director Southwest Asia Office, Ministry of Economy Trade and Industry (METI) from Japan side. During the meeting both sides discussed the proposed skill development/training in 5S and Kaizen at identified technology centres of Ministry of MSME by Association for Overseas Technical Cooperation and Sustainable partnership (AOTS) of Japan.

PROGRESS UPDATE

O1. CREDIT SCHEME

i. Credit Guarantee Scheme:

Ministry of MSME, is implementing Credit Guarantee Scheme for Micro and Small Enterprises through Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), for providing collateral free loan up to a limit of Rs. 5 crore (w.e.f. 01.04.2023) to MSEs with a guarantee coverage up to 85% for various categories of loans. a) Under the scheme, 1,05,770 guarantees amounting to Rs. 12,850 crore have been approved in July, 2023 whereas as on 23.08.2023, 79,153 guarantees amounting to Rs. 11,034 crore have been approved in August, 2023, taking the total guarantees approved to 4.19 lakh guarantees amounting to Rs. 54,383 crore during FY 2023-24 (upto 23.08.2023).

ii. Aatmanirbhar Bharat Package - Self Reliant India (SRI) Fund :

Self Reliant India (SRI) Fund is aimed at infusing Rs. 50,000 crore as equity funding in those MSMEs which have the potential and viability to grow and become large units. Total fund of Rs. 50,000 crore has a provision of Rs.10,000 crore from GoI and Rs. 40,000 crore leveraged through Private Equity / Venture Capital funds. In the month of June, July and August, 2023, 45 Daughter funds were empanelled and financial assistance provided to 1027 potential MSMEs by way of investing about Rs. 14,609 crore.





02. **TECHNOLOGY**

a. Tool Room & Technical Institutions

- 18 Tool Room & Technical Institutions spread across the country are providing trained personnel and are assisting MSMEs for various job works, testing & calibration, consultancy services such as designing and manufacturing of dies and tools, moulds etc. 8064 units were assisted by these Tool Room & Technical Institutions in June, July and August, 2023.
- Tool Rooms & Technical Institutions also undertake import substitution initiatives towards realizing Aatmanirbhar Bharat. In the month of June 2023, Bracket used in SUKHOI-30 AirCraft which is being imported from Russia was manufactured by the Tool Room under the Ministry located at Aurangabad for Indian Air Force. Tool Room, located at Bhubaneswar, has manufactured components of Light Combat Aircraft to Hindustan Aeronautics Limited, Lucknow.
- Tool Room at Bhubaneswar has developed parts for laser guided-missile for Defence Research and Development Organisation (DRDO), Hyderabad. Machining of a critical gearbox of Kaveri Engine (Aircraft Engine) was done for the CSIR-Central Mechanical Engineering Research Institute, Durgapur.
- To augment the network of Technology Centres, under the Scheme, "Establishment of new Technology Centres /Extension Centres", 20 new Technology Centres (TCs) as "Hub" and 100 Extension Centres (ECs) as "Spoke" are being established across the country. Locations for 5 more ECs were approved in June, 2023, and land at 7 locations have been brought under possesion of the Ministry upto August, 2023; taking the total of approved locations of ECs to 40. Further, 18 ECs have started imparting training and have trained 2762 trainees till August, 2023. Business/ technical advisory services to 35 MSMEs/ trainees/ Industries/ Entrepreneurs have also been provided by these ECs. Tender evaluation is under process to engage CPSEs for setting up of 20 TCs and 65 ECs.

b. Contribution by Tool Rooms of the Ministry in 'Chandrayaan-3' mission

India's third lunar mission, 'Chandrayaan-3' was successfully launched on 14.07.2023. In this remarkable mission, following Tool Rooms under the Ministry have made their contribution towards realizing 'Aatmanirbhar Bharat':

- Central Tool Room & Training Centre (CTTC), Bhubaneswar has manufactured and supplied
 437 types of precision components (around 54,000 components) for the mission.
- Institute for Design of Electrical Measuring Instruments (IDEMI), Mumbai has manufactured and supplied guiding device used in turbocharger assembly of the Chandrayaan-3.

c. Technology Centre Systems Programme

- Under the World Bank assisted "Technology Centre Systems Programme" (TCSP), 15 new Technology Centres (TC) are being established and modernizing of existing TCs are being done.
- MSME-TC, Durg assisted in designing power & control circuits of 15 Ton industrial EOT Crane for M/s Gearcon Engineering, Rajnandgaon for supply and installation to M/s Vedanta Group.
- MSME-TC, Sitarganj has carried out machining works for M/s PES Engineers Pvt. Ltd., Sitarganj and M/s Ghaziabad Precision Products Pvt. Ltd., Sitarganj.

d. MSME Champions Scheme

- MSME Champions Scheme has been formulated with three components namely, 'MSME-Sustainable' (ZED), 'MSME-Competitive' (LEAN) and 'MSME-Innovative' (Incubation, Design, IPR). Digital MSME will be interlinked with all other components of the Scheme
- RFP for engagement of Nodal Implementing Agency was uploaded on Central Public Procurement Portal (CPP) on 23.05.2023 for Digital MSME Scheme.
- 13 Awareness Programmes were organized by MSME Development and Facilitation Offices (DFOs) on World Intellectual Property Day under the IPR component of MSME Innovative scheme.
- Fifth Project Monitoring and Advisory Committee (PMAC) meeting of MSME Innovative Scheme (a component under MSME Champions Scheme) was held under the Chairmanship of Additional Secretary and Development Commissioner (MSME) on 14.07.2023, during which approvals were accorded for conducting 49 awareness programmes, National IP outreach Mission in 500 Aspirational Blocks, 30 IP Yatras in major cities, 'GI Mahotsav' in 10 States and conducting 5 capacity building training programmes for officials of MSME- Development and Facilitation Offices.
- Fourth Project Monitoring and Advisory Committee (PMAC) meeting of 'MSME Lean (Competitive) Scheme' was held under the Chairmanship of Additional Secretary and Development Commissioner (MSME) on 03.08.2023, during which approvals were accorded for conducting 793 awareness programmes, 20 consultant training programmes, 260 Intermediate-level and 65 Advance-level Lean certification targets for Group of Enterprise (GoE) formation.
- Third Project Monitoring and Advisory Committee (PMAC) meeting of 'MSME Sustainable (ZED) Scheme' was held under the Chairmanship of Secretary (MSME) on 23.08.2023, during which approvals were accorded for conducting 100 awareness programmes, 10 consultant training programmes, financial assistance for 500 testing /system/ product certifications, ZED certification targets of 50,000 Bronze Certifications, 150 Silver Certifications and 250 Gold Certifications.

54 Common Facility Centres (CFCs) and Infrastructure Development (ID) projects have been Geo-tagged, in the month of August, 2023, taking the total of Geo-tagged CFCs and ID Projects to 306, witnessing 21.4% increase in Geo-tagging of projects, when compared with the previous month

04. MARKET ACCESS

Vivad se Vishwas I - Relief to MSMEs

"Vivad se Vishwas I - Relief to MSMEs" scheme which was announced in the Union Budget 2023-24 was launched by the Department of Expenditure, Ministry of Finance, for providing relief to MSMEs for COVID-19 period. Ministry of MSME has requested all field offices of the Ministry to organize seminar/ workshop/awareness programmes for dissemination of information among all stakeholders to enhance outreach to MSMEs. All Ministries were also requested to expedite early settlement of pending claims.

Public Procurement Policy for Micro and Small Enterprises

Implementation of Public Procurement Policy for Micro and Small Enterprises is monitored through 'MSME SAMBANDH' portal. As per the portal, during the FY 2023-24, as on 30.08.2023, out of total procurement of Rs. 32,441.78 crore reported by 84 CPSEs and one Department, total procurement from MSEs is

Rs. 13,091.29 crore (40.35%) benefitting 52,746 MSEs, out of which Rs. 289.13 crore (0.89%) is from 1,840 MSEs owned by SC/STs and Rs. 381.61 crore (1.18%) is from 4,000 MSEs owned by Women.

• Ministry of MSME has participated in the meeting conducted by The Department for Promotion of Industry and Internal Trade (DPIIT) on 28.08.2023 to deliberate upon the issues raised by Indian Oil Corporation Limited regarding concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

PRIME MINISTER'S EMPLOYMENT GENERATION PROGRAMME (PMEGP)

PMEGP is a major credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector.

- The maximum project cost admissible for setting up a new project is Rs. 50 lakhs in Manufacturing Sector and Rs. 20 lakhs in Service Sector. The subsidy varies from 15% to 35% of project cost based on various geographical & demographical criteria.
- On the occasion of 'Udyami Bharat-MSME Day' celebrated by the Ministry of MSME at VigyanBhawan on 27.06.2023, Rs. 400 cr. Margin Money subsidy was digitally transferred by Minister (MSME) benefiting 10,075 PMEGP beneficiaries.
- During June 2023, 13,717 units were assisted with MM subsidy of Rs. 549.91 crore, generating estimated employment opportunities for 109,736 people.
- In FY 2023-24 till 30.06.2023, 20,536 units were assisted with MM subsidy of Rs. 850.23 crore, generating estimated employment opportunities for 164,288 people.

PM Vishwakarma Scheme

The Cabinet Committee on Economic Affairs chaired by Hon'ble Prime Minister approved a new Central Sector Scheme "PM Vishwakarma" on 16.08.2023 with a financial outlay of Rs.13,000 crore for a period of five years (FY 2023-24 to FY 2027-28). The scheme aims to strengthen and nurture the Guru-Shishya parampara or family-based practice of traditional skills by artisans and craftspeople working with their hands and tools. The scheme also aims at improving the quality, as well as the reach of products and services of artisans and craftspeople and to ensure that the Vishwakarmas are integrated with the domestic and global value chains.

Under PM Vishwakarma scheme, the artisans and craftspeople will be provided recognition through PM Vishwakarma certificate and ID card, Credit Support upto Rs. 1 lakh (First Tranche) and Rs. 2 lakh (Second Tranche) with a concessional interest rate of 5%. The Scheme will further provide Skill Upgradation, Toolkit Incentive, Incentive for Digital Transactions and Marketing Support.



The scheme will provide support to artisans and craftspeople of rural and urban areas across India. Eighteen traditional trades will be covered in the first instance under PM Vishwakarma. These trades include (i) Carpenter (Suthar); (ii) Boat Maker; (iii) Armourer; (iv) Blacksmith (Lohar); (v) Hammer and Tool Kit Maker; (vi) Locksmith; (vii) Goldsmith (Sonar); (viii) Potter (Kumhaar); (ix) Sculptor (Moortikar, stone carver), Stone breaker; (x) Cobbler(Charmkar)/ Shoesmith/ Footwear artisan; (xi) Mason (Rajmistri); (xii) Basket/Mat/Broom Maker/Coir Weaver; (xiii) Doll & Toy Maker (Traditional); (xiv) Barber (Naai); (xv) Garland maker (Malakaar); (xvi) Washerman (Dhobi); (xvii) Tailor (Darzi); and (xviii) Fishing Net Maker.

Participation of artisans in 77th Independence Day celebrations at New Delhi

On the occasion of 77th Independence Day celebrations, among the 1,800 Special Guests who have been invited by the Government of India for the National Flag hoisting ceremony by Hon'ble Prime Minister at Red Fort.
