



The Golden Fibre: Ensuring
Sustainable Rural Livelihoods

comes from coconuts. It's the fibrous husks of the inner shell of the coconut and is used for all variety of products, including rugs, ropes, brushes, and even upholstery stuffing. The first recorded history of golden fibre in the country dates back to Ramayana period. In the Valmiki's Ramayana there



are references of coconut in the Kishkindha Kanda and Aranya Kanda. Ropes and cordage, made out of coconut fibre have been in use from ancient times. Indian navigators, who sailed the seas to Malaya, Java, China and to the Gulf of Arabia centuries ago, had been using Coir as their ship's cables. The Coir manufacturing

industry producing Coir mats, matting and other floor coverings started in India on a factory basis, over a hundred years ago when the first factory was set up in Alleppey in 1859 by the Late Mr. James Darragh, adventurous an Irish born American national. Enterprising Indians followed the trail blazed by this foreigner.

Alleppey (Alappuzha in Malayalam) is the nerve centre of Kerala's famous Coir industry. Here, one can coconut husks being beaten into fibre for making beautiful mats and other Coir products. Both men and women are actively involved in the production of Coir. Coir Industry enjoys the status of largest Cottage Industry in the State of Kerala, giving employment to over a million people.

The absence of awareness about the upsides of Coir and its by-products, hesitance of artisans to utilize them, non-accessibility of a critical mass of items in the these market are major hurdles their on to getting approach potential consumers.

Coir Board was set up under the Coir Industry Act, 1953 by the Government of India for Creating awareness and the overall sustainable development of the Coir industry in the Country. The Board functions under the Ministry of Micro, Small and Medium Enterprises.

The functions of the as laid down Board under the Act; includes undertaking, assisting, and encouraging scientific, technological, and economic research, modernization, quality human improvement, resource development, market promotion, and welfare of all those who are engaged this industry. For the last more than 60 years Coir Board is steering the industry and the industry today plays a vital role in the economic development of rural areas of the country. The Coir industry sustains predominantly women, in different states of the country. It is estimated that around 80% of the workforce in the industry are women and it plays a role in rural women's empowerment in many

coastal districts of the country. Under PMEGP (Prime Minister's Employment Generation Programme), Coir Units have been started in different states of the country.

While many industries recorded a dip in the export of their products after COVID-19, the Coir and Coir products from India registered an all-time-high record of around 11.63 lakh metric tonne, worth Rs 3,700 crore, during the pandemic period of 2020-21.

Coir is a material which is widely used to overcome the problem of erosion. When woven into geotextiles and placed on areas in need of erosion control it promotes new vegetation by absorbing water and preventing top soil from drying out.

The Coir Board's Research Institutes are undertaking new R&D projects in Coir with various CSIR units and Universities.

New end-use applications of Coir like the use of Coir Geotextiles for preventing soil erosion, conversion of Coir Pith into valuable bio-fertilizer and soil conditioner, and Coir Garden articles have popularity gained India and abroad.

The growing affinity towards environment-friendly products has helped Coir and Coir products in domestic as well as foreign markets.

Coir Geo Textile is naturally resistant to rot,

naturally resistant to rot, molds and moisture, and free from any microbial attack hence it needs no chemical treatment. Coir Geotextiles are also used for construction of rural roads under Pradhan Mantri Gram Sadak Yojana.

Hon'ble Union Minister for MSME, Shri. Narayan Rane and Hon'ble Minister of State for MSME, Shri Bhanu Pratap Singh Verma along with other State Ministers and senior officials

inaugurated the 'Enterprise India National Conclave 2022'. Speaking on the occasion Shri. Narayan Rane emphasized the on development of new products and new applications coir through product development, product

diversification & adoption of new technologies.

On this occasion, Coir industry awards were distributed to 44 Coir & Coir products manufacturing /exporting units.

Coir Board also introduced Coir new products like Coir composite fruit bowl, geo-textile shadow lamp, Coir buttons, auto mirror covers made of Coir, flat rectangular tray, certificate holder as well as released Manual of Technologies for Coir, Books on Coir pith, geo-textiles and Coir floor furnishing.

The major objective of the Conclave was to create an effective platform for discussion and interaction between the Central and State/UT functionaries concerned with the Coir industry. The Conclave deliberated on the issues, challenges and opportunities in the coir sector in each State/UT in and the country as a whole.





'Run for Coir' was also organized on 6th May, 2022 to promote the use of Coir, as a natural, degradable, eco-friendly product. More than thousand people, including dignitaries, college students and the public general participated in the run. Coir products are benign environmentally and have received "Eco Mark" certification from the Ministry of

Environment and Forests of the Government of India.

Initiatives to promote the Coir industry

Coir Udyami Yojana is a credit-linked subsidy scheme for setting up Coir units with project cost up to Rs. 10 lakhs plus one cycle of working capital, which shall not exceed 25% of the project cost. The scheme is being implemented by the Coir Board.

The Coir Vikas Yojana **scheme** facilitates the development of domestic and export markets, skill development and training, empowerment of women, employment/entrepreneurship creation development, enhanced raw material utilization, trade-related services, and welfare activities for the Coir workers, etc.




O3. 3rd Meeting of the Asia-Pacific Policymakers Network

Credit Guarantee Scheme for Subordinate Debt (CGSSD):

- It is operationalized through a special window created for this purpose under Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE).
- As reported by Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), under the Credit Guarantee Scheme – Subordinate Debt (CGSSD) for stressed MSMEs during the

month of May, 2022 (upto 24.05.2022), 2 guarantees have been approved involving an amount of Rs. 0.27 crore.

• During the current FY 2022-23 (from 01.04.2022 to 24.05.2022), 8 guarantees involving an amount of Rs. 2.51 crore have been approved.

Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE):

- During the month of May, 2022 (upto 25.05.2022), as per the data provided by CGTMSE, 61,188 guarantees have been approved involving an amount of Rs. 4,169 crores.
- During the current FY 2022-23 (from 01.04.2022 to 25.05.2022), 1,19,789 guarantees involving an amount of Rs. 9,538 crores have been approved.

Prime Minister Employment Generation Programme (PMEGP):

 Margin Money Subsidy of Rs. 367.48 Cr was disbursed by banks upto 31.05.2022, under the 'Prime Minister's Employment Generation Programme' (PMEGP) Scheme which will create estimated employment of around 103064 persons.

Capacity Building and Augmentation:

Training & Placement:

- 14,975 persons have been imparted skill training through various organizations under the Ministry, i.e., Tool Rooms & Technical Institutions, New Technology Centre's established under TCSP, National Small Industries Corporation (NSIC) Ltd., Khadi and Village Industries Commission (KVIC), Coir Board etc. during the month of May, 2022.
- 200 trainees trained by MSME Tool Rooms & Technical Institutions viz., CTTC Bhubaneswar, IDTR Jamshedpur and its extension Centre, Tool Room & Training Centre (TRTC), Patna have been placed in various enterprises.
- NI-MSME has conducted valedictory Programme for capacity building Programmes sponsored under National SC/ST Hub Scheme, Ministry of MSME on 6th May 2022 at NI-MSME campus. A total of 480 students were trained for 45 days in various capacity building Programmes such as Business Development Executive, Communication & Soft Skills, Accounts Executive & Sales Manager
- Tool Room & Training Centre (TRTC), Guwahati has undertaken following major activities during the month of May, 2022:-
 - Trained 461 candidates in various NCVT/SCVT Certificate and Diploma courses such as Machinist, Turner, Welder, Computer Hardware & Network Management, Steel Fabrication, Plumber, CNC Machining, CAD/CAM, PLC, Auto CAD & Catia etc.

- Rendered services to 59 units including MSMEs by manufacturing of tools & components.
- 56 trainees have been placed in different industries of Assam.

Assistance and Handholding:

During the month of May, 2022, 18 Tool Rooms & Technical Institutions under the
Office of Development Commissioner (MSME) assisted 2,545 units for various job
works, testing & calibration, consultancy services such as designing and
manufacturing of dyes and tools, moulds, jigs and fixtures, CAD/CAM, etc

Extension Centers (EC):

- 35 locations for ECs have been approved, out of which, Detailed Project Reports (DPRs)
 of 26 ECs have been approved. These Extension Centres are in the process of
 establishment.
- 17 ECs have started training / assisting MSMEs. In the month of May 2022, 15 ECs have trained 1,198 trainees and assisted 30 MSMEs.

COIR Board:

 21 firms were newly registered as Coir Exporters and issued Registration-cum-Membership Certificates in May, 2022.

MSME Champions Scheme:

- Under MSME-Sustainable (ZED) component of 'MSME Champions' Scheme, Rs. 1.31 crore has been released to MSME-Development Institutes for conducting 240 Awareness Programmes.
- During the month of May 2022, 7,045 MSMEs have been registered for ZED registration on ZED Portal, out of which 50 MSMEs have been "Bronze" certified.



01. National conference of MSME- Development Institutes, Testing Centres and Technology Centres

Ministry of MSME organized National conference of MSME-Development Institutes, Testing Centres and Technology Centres on 10th May 2022 at New Delhi. The aim of organizing this conference was to interact with field officials of the Development Commissioner (MSME), and the Ministry of MSME to make future plans for better implementation and monitoring of MSME schemes and coordination with State Governments and other stakeholders for the benefit of the MSMEs.
