

## SPECIAL CAMPAIGN 2.0

he first ever Special Campaign was launched in 2021, with the objective of reducing pendency government various departments and making swachhata a people's movement. Various steps were taken to reduce the number of rental premises which were not in use and judicious maintenance of the government files and getting rid of the obsolete ones. In other words. record management activities of the government offices were to be improved. In 2021's Special Campaign about 62 crores of the scraps were disposed off. This campaign was carried out at various verticals in numerous government departments. On the successful completion of Special Campaign in 2021, The Government of India started its Special Campaign 2.0 from 2<sup>nd</sup> October to 31<sup>st</sup> October. 2022 with a focus on Swachhata and reducing pendency in the Government.

The Special Campaign 2.0 places a emphasis greater field/outstation offices in addition to the Ministries, Departments, and their subordinate offices. The objective of this campaign is to institutionalise cleanliness government departments and to sensitise government officials about cleanliness. It also aims to provide a good experience to the people who come to government offices with their problems and recommendations. of Administrative Department Reforms and Public Grievances (DARPG) oversees implementation of the campaign. Union Minister of State for Ministry of Personnel, Public Grievances, Pensions Jitendra Dr launched the Special Swachhta Campaign 2.0 on 02.10.2022. The Special Campaign 2.0 launched on "Bapu Jayanti" from 2nd October to 31st October, 2022 aims at ensuring timely and effective disposal of Public Grievances,

#### **MSME SAMBANDH - Public Procurement Policy**

IImplementation of Public Procurement Policy for Micro and Small enterprises is monitored through 'MSME SAMBANDH' portal. Upto 30.09.2022, the procurement details of Central Public Sector Enterprises (CPSEs) during FY 2020-21, FY 2021-22 & FY 2022-23 are as follows-

MSME SAMPARK portal is a digital platform wherein jobseekers (passed out trainees/students of Tool Rooms & Technical Institutions) and recruiters get connected. Progress of SAMPARK portal for September, 2022 (as on 24.09.2022) is given below:



#### Self Reliant India (SRI) Fund

As reported by NSIC Venture Capital Fund Limited (NVCFL), 31 Daughter funds have been empanelled under the SRI Fund and under the aegis of NVCFL (Mother Fund) as of now, financial assistance to 94 potential beneficiaries have been extended by the Daughter funds. For Implementation of SRI Fund Scheme, Rs 51.20 crore has been released by NVCFL during the Month of September, 2022.

#### Credit Guarantee Scheme for Subordinate Debt (CGSSD)

It is operationalized through a special window created for this purpose under Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE).

As reported by Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), under the Credit Guarantee Scheme- Subordinate Debt (CGSSD) for stressed MSMEs during FY 2022-23 (from 01.04.2022 to 25.09.2022), 14 guarantees involving an amount of Rs. 4 crore has been approved.

#### Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE)

During the month of September, 2022 (upto 25.09.2022), as per the data provided by CGTMSE, 69,631 guarantees have been approved involving an amount of Rs.7,757 crore. During FY 2022-23 (from 01.04.2022 to 25.09.2022), a total of 4,46,591 guarantees involving an amount of Rs. 39,484 crore have been approved.

#### Prime Minister's Employment Generation Programme (PMEGP)

Margin Money Subsidy of Rs.934.62 Cr was disbursed by banks upto 30.09.2022, under the 'Prime Minister's Employment Generation Programme' (PMEGP) Scheme which will create estimated employment of around 2,29,464 persons.

#### Capacity Building and Augmentaion

#### Training & Placement:

- (i) 22,751 persons have been imparted skill training through various organizations under the Ministry i.e., Tool Rooms & Technical Institutions, New Technology Centre's established under TCSP, National Small Industries Corporation (NSIC) Ltd., Khadi and Village Industries Commission (KVIC), Coir Board, etc. during the month of September, 2022.
- (ii) 245 trainees trained by MSME Tool Rooms & Technical Institutions viz, CTTC Bhubaneswar, IDTR Jamshedpur and its extension Centre, Tool Room & Training Centre (TRTC), Patna have been placed in various enterprises.
- (iii) Tool Room & Training Centre (TRTC), Guwahati has undertaken following major activities during the month of September, 2022-
  - Trained 1,925 candidates in various NCVT/SCVT Certificate and Diploma courses such as Machinist, Turner, Welder, Computer Hardware & Network Management, Steel Fabrication, Plumber, CNC Machining, CAD/CAM, PLC, Auto CAD & Catia etc.
  - Rendered services to 113 units including MSMEs by manufacturing tools & components.
  - 50 trainees have been placed in different industries of Assam.



#### **Assistance and Handholding**

During the month of September, 2022, 18 Tool Rooms & Technical Institutions under the Office of Development Commissioner (MSME) assisted 2,489 units for various job works, testing & calibration, consultancy services such as designing and manufacturing of dies and tools, moulds, jigs and fixtures, CAD/CAM, etc



#### **Extension Centres (ECs)**

35 locations for ECs have been approved, out of which, Detailed Project Reports (DPRs) of 26 ECs have been approved.

18 ECs have started training / assisting MSMEs. In the month of September 2022, 15 ECs have trained 1,198 trainees and assisted 30 MSMEs.



#### **MSME Champions Scheme**

During the 3rd Project Monitoring & Advisory Committee (PMAC) meeting of 'MSME Innovative' scheme held under the chairmanship of Additional Secretary & Development Commissioner (MSME) on 27.09.2022, following proposals have been approved:

- Theme-based 'MSME Idea Hackathon 2.0' was approved under the sub-component 'Incubation' of 'MSME-Innovative' Scheme.
- · In-principle approval for 25 new Host Institutes (HIs).
- 17 Design Projects have been approved.

8 firms were newly registered as Coir Exporters and issued Registration- Cum Membership Certificates in September, 2022.
